Application Package Requirements Checklist

1. TSA Citizenship Requirements

Any U.S. citizen applying for training to be used towards a **recreational, sport pilot, private pilot (single or multiengine) certificate, multiengine rating at any level, or instrument rating**, in an aircraft weighing less than 12,500 pounds must present the flight school or flight instructor with evidence of U.S. citizenship. Evidence may be shown by one of the following:

- Valid unexpired U.S. passport
- Original birth certificate of the United States, American Samoa, or Swains Island, and government-issued picture ID
- Original U.S. naturalization or citizenship certificate (Form N-550 or N-570) with raised seal and government-issued picture ID
- Original certificate of U.S. citizenship with raised seal (Form N-560 or N-561), or a Certificate of Repatriation (Form N-581), and government-issued picture ID
- Original certification of birth abroad with raised seal (Form FS-545 or DS-1350) and government-issued picture ID.

Any non-citizen will require a TSA waiver to enter flight training. Provide proof of your legal alien status.

2. A copy of the applicant's recent transcript or report card must accompany this application.
3. The applicant shall write a short essay - 350 words or less. The essay will convey why attendance in Red-Tailed Hawks FLY is important to them, and state their commitment to complete the two-week program. Include the essay with the application.
4. The applicant will acquire, at least, two letters of recommendation (LoR) from teachers, counselors, or youth program leaders familiar with their behavior and academic discipline. Each LoR must include the writer's phone number, mailing address, and email. Include the LoRs with the application.
5. Mail the application with attachments to Red-Tailed Hawks Flying Club, Po Box 1403, Mukilteo, WA 98275. **Use the "Application Package Requirements Checklist" to ensure all required materials are included.** Scan a copy of your application package for your records.

Incomplete applications will not be considered. Applications are due May 15th.
